WHEREAS, the Town Board of the Town of Elba, New York desires to consider adopting legislation to override the limit on the amount of real property taxes that may be levied by the Town of Elba pursuant to General Municipal Law § 3-c, and to allow the Town of Elba to adopt a town budget for fiscal year 2019 that requires a real property tax levy in excess of the tax levy limit, also known as Town of Elba Local Law No. 2 of 2018.

NOW, THEREFORE, BE IT RESOLVED by the Town Board for the Town of Elba, New York that proposed Local Law No. 2 of 2018 entitled "A Local Law to Override the Tax Levy Limit Established in General Municipal Law § 3-c", which proposed Local Law is now in its final form as appears by a copy thereof hereto attached, be and the same hereby is introduced for adoption; and

BE IT FURTHER RESOLVED that said proposed Local Law was given to the members of this Town Board on this date and remain with them and a copy thereof be kept on file in the office of the Town Clerk until November 8, 2018, and that a public hearing be held before this Town Board on the 8th day of November 2018 at 7:00 p.m. at the Elba Town Hall, 7 Maple Avenue, Elba New York, on the advisability of enacting said proposed Local Law; and **BE IT FURTHER RESOLVED** that the Town Clerk shall cause notice of said public hear to be published once in the <u>The Daily News</u> at least five (5) days prior to the date of said public hearing, which notice shall contain the time and place of said hearing, the title and purpose thereof, as well as a statement that a copy of said proposed Local Law is on file in the Town Clerk's Office.

Section 1. Legislative Intent

It is the intent of this local law to override the limit on the amount of real property taxes that may be levied by the *Town of Elba page 2 of 9 October 11, 2018*

Town of Elba pursuant to General Municipal Law §3-c, and to allow the Town of Elba to adopt a budget for the fiscal year 2019 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law §3-c.

Section 2. Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes the town board to override the tax levy limit by the adoption of a local law approved by vote of sixty percent (60%) of the town board.

Section 3. Tax Levy Limit Override

The Town Board of the Town of Elba, County of Genesee, is hereby authorized to adopt a budget for the fiscal year 2019 that requires a real property tax levy in excess of the amount otherwise proscribed in General Municipal Law, §3-c.

Section 4. Severability

If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjusted by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in it separation to the clause, sentence, paragraph, subdivision, or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 5. Effective Date

This local law shall take effect immediately upon filing with the Secretary of State.

Building and Grounds

<u>GAM</u>

The Genesee County Legislature conducted a Public Hearing on mandated public sector shared service plans. All towns and villages are in favor with the exception of one.

The sales tax renewal agreement was discussed. The towns and villages will receive payments from the County at a level capped at the 2018 sales tax distribution amount of 34%.

Discussion ensued at the GAM meeting regarding the State mandate on a new jail. The estimated cost of this project is \$50 million. A committee has been formed to work out the details.

Cemetery

The town received a request from a former resident to buy her cemetery plot back. Town Clerk Werth sent the request to Town Attorney David Schubel to review. Mr. Schubel's thought is to develop a policy. We will investigate policies to bring back next month.

Publicity

A request to propose an offer on cleaning the Town Hall's carpet was received from a resident. There is no interest at this time.

DEPARTMENT REPORTS

<u>Highway</u>

The salt has arrived and is mixed together.

Town of Elba

- The MEO's are helping the County through shared service agreements.
- There are a couple of trees that will need to be cut soon.
- The Village would like help in wedging Chapel Street soon.
- MEO's and Mr. Yungfleisch will start preparing the trucks and equipment for winter soon.
- There is a headstone in the shop from a movie that was filmed in Town. Mr. Yungfleisch will give it to the Historical Society.
- Mr. Yungfleisch is not interested in the truck that he checked out earlier this month. He will get the specifications for a truck similar to the last one and see where prices are.

Councilwoman Marshall asked about the reflectors on Edgerton Road – Mr. Yungfleisch stated these are in areas where there is a dip in the road or a culvert pipe nearby.

Councilwoman Marshall also asked about the pink flags along the roadway throughout town. These are from the soil bores taking place.

Assessor

ZEO/CEO

Mr. Mikolajczyk's report was emailed and is also available in the Town Clerk's office.

Town Clerk

Town Clerk Werth reported that she took in \$1,390.59 and remitted \$1,325.09 to the Supervisor for local share, \$43.00 to NYS Ag. & Markets for spay/neuter program and \$22.50 to NYS DOH. A total of three new dogs were licensed and 36 licenses were renewed. We also had a total of 48 conservation customers.

We continue to collect the Water Service Applications for the Town of Batavia. A total of 11 residents applied in September.

<u>Supervisor</u>

Supervisor Hynes reported that she and Barry Flansburg met with Matt Smith and Jeff Smith from Municipal Solutions and Jason Foote of CPL last week to review the numbers for WD2. Phase 3 is currently out to bid and Phase 4 will go out as soon as the property is settled with the lawyers. Therefore, they recommend the Town to finish borrowing the remainer of the \$8 million for WD2.

Councilpersons/Miscellaneous

Councilwoman Marshall mentioned the Public Hearing for the Fire District on October 16th. In the future she would like to see the Town Board and Fire District have conversations beforehand to keep everyone in the loop. Supervisor Hynes and Councilman Coughlin will try to attend their Public Hearing.

NEW BUSINESS

Mr. Yungfleisch stated the fax machine has not been working properly. He will have someone come in and look at the lines.

Mr. Yungfleisch spoke with Randsco today. They will be returning on October 17th. They will finish Phase 1 and then start working on the Town roads of Phase 2 and then move onto the State highways.
