ORDER CALLING PUBLIC HEARING

TO BE HELD ON JULY 11, 2019 AT 7:00 PM (PREVAILING TIME)

WHEREAS, the Town Board of the Town of Elba formed Elba Water District No. 2 in accordance Town Law Article 12-A, a Final Order Establishing District having been duly adopted July 19, 2017, a certified copy of which having been recorded in the Genesee County Clerk's Office on July 21, 2017, and

WHEREAS, the Final Order provided that Water District No. 2 was to be constructed at a maximum cost not to exceed \$17,769,000.00, and

WHEREAS, the Town Board of the Town of Elba wishes to increase the maximum amount to be expanded for construction of Water District No. 2 from \$17,769,000.00 to \$18,764,000.00 due to significant upgrades to the overall Genesee County Water System, and

WHEREAS, the upgrades include the County of Genesee making a financial contribution to the Town of Elba to upsize the Town of Elba Water storage tank and to upsize certain of the Town's water mains from 8 inches to 12 inches, and

WHEREAS, to simplify the construction coordination and reduce costs, the County's improvements will be completed as part of the Town of Elba Water District No. 2 project, and

WHEREAS, a revised map, plan and report has been prepared by Clark Patterson Lee dated June 2019, which engineers are duly licensed in the State of New York, and which revised map, plan and report is on file in the office of the Elba Town Clerk for public inspection, and

WHEREAS, the maximum amount to be expended for construction as stated in the revised map, plan and report is increased from \$17,769,000.00 to \$18,764,000.00, and the entire additional amount of \$995,000.00 to be expended is to be paid by Genesee County as more particularly set forth in an Intermunicipal Agreement between Genesee County and the Town of Elba, a copy of which is enclosed as an appendix to the revised map, plan and report, and

WHEREAS, the original map, plan and report estimated the cost of the district to a typical one or two family home in the amount of \$1,035.00, and the revised map, plan and report now estimates the cost of the district to a typical family home in the amount of \$1,044.00, the \$9.00 increase as a result of the estimated yearly water cost with the estimated debt service of \$738.00 the same in each map, plan and report, and

WHEREAS, the Town of Elba Town Board proposes to increase the maximum amount to be expended and to conduct a hearing with respect to same and to hear all persons interested in the subject thereof and concerning the same in accordance with the provisions of section 209-h of the Town Law, and

WHEREAS, the New York State Comptroller's approval is required for such increase.

NOW THEREFORE BE IT:

ORDERED, that the Town Board of the Town of Elba meet and hold a public hearing at the Elba Town Hall, 7 Maple Avenue, Elba, New York on the 11th day of July 2019 at 7:00p.m. (Prevailing Time) to consider

Building and Grounds

GAM

Councilwoman Marshall attended the meeting. They started off with the jail input meeting, this will cost approximately \$60 million. There is also discussion to add a courtroom and have the town and village judges alternate. There are exploring opportunities for the old courthouse.

Other topics included a sales tax report from Scott German, Randsco was awarded the County's Phase 2 water project, and there is concern of water shortage.

Councilman Chamberlain has not received anymore information from the family who would like to use a stone versus a traditional headstone.

Highway

Superintendent of Highways Yungfleisch reported:

- They will be sealing up two roads that were done last year. They will also stone Ridge Road.
- 15 culverts need to be replaced when it dries out.
- No roadwork will take place until the water project is completed.

Councilwoman Marshall heard NYS will be replacing a bridge at the intersection of Spoilbank Road and Hundredmark Road through the NYS Bridge grant program. Mr. Yungfleisch confirmed this will take place in 2020.
