Public Participation

Mrs. Pauli Miano was in attendance to answer any questions regarding the Richter Foundation annual request. Supervisor Hynes informed Mrs. Miano the Town could only distribute \$600.00 this year.

Mrs. Miano stated the Betterment Committee was successful in a grant they applied for with Go Art. This will help the Committee bring approximately six bands along with other activities and food to the Village Park during the summer of 2020. They are working out the details and could always use new community members to help.

Justice Doug King was present to discuss the criminal justice reform update. A couple of highlights include the elimination of cash bail for most offenders, more state certified interpreter services will be required, and the paperwork of the judges, court clerks, DA's, etc. will increase. These mandated updates may lead to the need for pay increases for the judges and court clerk in the future. Justice King encouraged the Board to voice their thoughts to local Legislators so they can pass on to the Governor.

WHEREAS, The Disaster Mitigation Act of 2000 (Public Law 106-390) established new requirements for pre and post disaster hazard mitigation programs; and

WHEREAS; a coalition of Genesee County municipalities with like planning objectives has been formed to pool resources and create consistent mitigation strategies within Genesee County; and

WHEREAS, the coalition has completed a planning process that engages the public, assesses the risk and vulnerability to the impacts of natural hazards, develops a mitigation strategy consistent with a set of uniform goals and objectives, and creates a plan for implementing, evaluating and revising this strategy;

NOW, THEREFORE, BE IT RESOLVED that the Town of Elba:

- 1) Adopts in its entirety, the 2019 Genesee County Hazard Mitigation Plan (the "Plan") as the jurisdiction's Hazard Mitigation Plan, and resolves to execute the actions identified in the Plan that pertain to this jurisdiction.
- 2) Will use the adopted and approved portions of the Plan to guide pre- and post-disaster mitigation of the hazards identified.
- 3) Will coordinate the strategies identified in the Plan with other planning programs and mechanisms under its jurisdictional authority.
- 4) Will continue its support of the Hazard Mitigation Steering Committee and Planning Partnership as described within the Plan.
- 5) Will help to promote and support the mitigation successes of all participants in this Plan.
- 6) Will incorporate mitigation planning as an integral component of government and partner operations.
- 7) Will provide an update of the Plan in conjunction with the County no less than every five years.

THIS AGREEMENT, made the 12th day of December, 2019 by and among the TOWN OF ELBA, with offices located at 7 Maple Avenue, Elba, New York 14058, (hereinafter referred to as the "Town"), and the VILLAGE OF ELBA, with offices located at 4 South Main Street, Elba, New York 14058 (hereinafter

referred to as the "Village"), and the **ELBA FIRE DEPARTMENT**, with offices located at 4 South Main Street, Elba, NY 14058 (hereinafter referred to as the "Fire Department"), and the **ELBA CENTRAL SCHOOL DISTRICT**, with offices located at 57 South Main Street, Elba, New York 14058, (hereinafter referred to as the "District").

WITNESSETH:

WHEREAS, the parties cooperatively use a common fuel dispensing station located on Town property adjacent to the Town Hall, currently consisting of two above ground storage tanks, and the appurtenances, one of which contains diesel fuel and once of which contains gasoline, and

WHEREAS, since approximately 1995 the parties have been jointly using and operating this station, and

WHEREAS, the parties have not found a written Agreement signed by all four parties, and

WHEREAS, the parties desire to place the terms and conditions for the future use and operation of this station in writing, as set forth herein.

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, it is agreed as follows:

1. Each party shall be jointly and equally responsible for any and all costs and expenses of any kind or nature related to the operation and maintenance of this system.
