WHEREAS, the Town of Elba (the "Town") and Webster, Schubel & Meier, LLP (the "Attorney") entered into a Legal Services Agreement (USDA form 1780-7) dated December 8, 2016 whereby the Attorney agreed to perform all legal services for the Water District No. 2 project at the rate of \$165.00 per hour, not to exceed \$20,625.00, and

**WHEREAS**, by Resolution No. 12-2019 the Town authorized an amended Legal Services Agreement so that the revised not to exceed amount was increased to the sum of \$31,250.00 to be paid at the rate of \$165.00 per hour, and

WHEREAS, pursuant to Resolution No. 12-2019, the Town and the Attorney entered into a Legal Services Agreement (USDA form 1780-7) dated April 11, 2019 whereby the Attorney agreed to perform all legal services for the Water District No. 2 project at the rate of \$165.00, not to exceed \$31,250.00, and

WHEREAS, given the unanticipated scope and volume of matters present in the Water District No. 2 project requiring legal services, the not to exceed amount of \$31,250.00 is insufficient, and

**WHEREAS**, the Town hereby determines that it is necessary and appropriate to raise the current not to exceed amount from \$31,250.00, NOW THEREFORE, be it

**RESOLVED**, the current not to exceed amount for legal services in the Water District No. 2 project be increased by the sum of \$13,750.00 so that the revised not to exceed amount shall be in the sum of \$45,000.00 to be paid at the rate of \$165.00 per hour, and be it further,

**RESOLVED**, that the Town Supervisor is hereby authorized to sign an amended Legal Services Agreement in form satisfactory to USDA Rural Development.

# APPROVE LEGAL SERVICES AGREEMENT AND AUTHORIZE SUPERVISOR TO SIGN BETWEEN THE TOWN OF ELBA AND WEBSTER, SCHUBEL & MEIER, LLP

**THIS AGREEMENT** made as of the 1<sup>st</sup> day of January, 2020 between the TOWN OF ELBA, am municipal corporation of the State of New York, hereinafter referred to as "TOWN" and DAVID C. SCHUBEL, Attorney at Law, of 113 West Center Street, Medina, New York, hereinafter referred to as "ATTORNEY",

**WHEREAS**, the Town requires legal services in connection with the operations and functions of the government of the Town, and

**WHEREAS**, the Attorney is experienced in matters involving municipal law and wishes to perform necessary legal services for the Town,

**NOW, THEREFORE**, in consideration of the premises and the mutual covenants and promises hereinafter set forth, it is agreed as follows:

Attorney will perform such legal services to the Town as authorized and requested by the Town during the term of this Agreement.

As compensation for the services as rendered, the Town will pay the Attorney at an hourly rate of \$195.00 per hour which shall be paid monthly in installments upon submission of vouchers therefor by the Attorney, payable upon audit and approval by the Town. The vouchered payments shall not be considered compensation for the purposes of the New York State Retirement System.

The Attorney will perform and provide such legal services as are required by the Town in connection with capital projects, bond issues, and other borrowings and other related matters, at rates and fees to be agreed upon between the parties by separate agreement for each matter.

The Lawyers' Code of Profession Responsibility prohibits representation of multiple clients if the exercise of independent professional judgement of behalf of a client will be or is likely to be adversely affected by such multiple representation. For the matters contemplated herein, the Town will be a client of the Attorney.

As a matter of course, Attorney regularly represents other municipalities and professionals who provide services to municipal entities. Attorney's representation of these clients has occurred in the past, is presently ongoing, and Attorney hopes will continue in the future.

If Attorney represents a regular client in matters not related to the Town, a "potential" conflict of interest may arise if such client subsequently becomes involved in a matter relating to the Town. Execution of this Agreement will constitute a waiver by the Town of all "potential" conflicts of interests, but will not constitute a waiver of an "actual" conflict of interest. An "actual" conflict of interest would exist in a situation where Attorney's firm represents the Town and another client in the same matter. In the event of an "actual" conflict of interest, Attorney will provide notice to the Town of such "actual" conflict of interest, and will undertake such appropriate steps to resolve any such "actual" conflicts of interest consistent with the Lawyer's Code of Professional Responsibility.

The terms of this Agreement shall be for the period of one (1) year from January 1, 2020, to December 31, 2020. This agreement may be terminated by the Town upon thirty (30) days written notice by certified mail return receipt requested or personal delivery.

# **Highway**

Mr. Yungfleisch had no report.

#### Assessor

Mr. Flansburg left a report stating:

"Attached is a list of the residential sales used by the State in developing sales trends and equalization rates. Sales the last two years showed a trend of 21.83%. On the 2019 role changes, I got roughly 7% of that number in changes and for 2020 I have about 3% of that number. If sales continue at this trend, there will be a land and structure increase for 2021 and another structure increase in 2022. If the current market trend continues, we will have assessment increases the next three years to try to keep values high enough for the

State to declare us at 100%. I have tentative approval that the increases for 2020 will get us 100% certification just barely. As you can see, what people sell their property for is what makes assessments go up. The market currently is very strong. Only three of the sales went for below assessed value and two of those were empty houses. 2020 change notices will go out in early March and there is very little data to show anyone is over assessed. Please let me know if you have any questions."

Mr. Mikolajczyk attended the Niagara Falls Builders Conference for his 24 hours certification on January 27, 28, 29, 2020.

## **Town Clerk**

Town Clerk Werth reported that she took in \$1,060.00 and remitted \$1,023.00 to the Supervisor for local share, \$37.00 to NYS Ag. & Markets for spay/neuter program.

Town Clerk Werth will attend the Annual NYSTCA Conference in Albany this year, April 26-29<sup>th</sup>.

Taxes are going well. The Town has received their portion of taxes collected, to date have sent \$790,000.00 to the County Treasurer. We will continue to collect through the end of March. Town Clerk Werth will go through the remaining taxes to ensure the owner information is current.

#### **Supervisor**

Supervisor Hynes reported the following:

Water District 2

• Phase 7 – Jason Foote advised the Board that they were able to reduce fees for Phase 6 and would like to move forward with plans for Phase 7. This phase will help eliminate dead ends, close loops (98 North of Ridge Road, Pekin Road gap, Edgerton Road gap, West Avenue gap and Hundredmark Road), help will water pressure and pick up users.

Supervisors Hynes made a **MOTION**, second by Councilman Coughlin to move forward with Phase7 as contingent on Rural Development's approval.

- Phase 6 There will be a change order submitted for this phase, no bid. Changes will include easement resubmitted to the Health Department, Rural Development and Sergi.
- Councilwoman Marshall asked if there was anything new with adding Byron residents on Transit Road. Jason Foote stated we can easily add out of district users, the Town of Byron would need to approve this. He would encourage those residents to approach their Town Board.
- Phase 4 Caldwell Manufacturing is here and assembling the tank. We need to discuss what color we would like it painted. Mr. Foote stated there is approximately \$25k available to paint/add enhancements. Mr. Yungfleisch stated we should consider paving the area around the tank with that money. Supervisor Hynes asked the Board to think this over and we will discuss at the next meeting.
- The next WD2 construction meeting is scheduled for February 26<sup>th</sup> at 9:00 a.m.

#### Other Business

- Supervisor Hynes reported that we closed on the bank property January 30, 2020. Meeting with CPL on February 26<sup>th</sup> to take measurements and discuss design plans. We need to get a door in place as soon as possible for access. Mr. Yungfleisch will also work with Denis Rohan, Village of Elba Public Works to install the door. Once this door is installed M&T will board up the current door near the ATM. Having a door in place will allow Mr. Yungfleisch and his MEO's to start tearing down and removing counters, cupboards, cabinets, etc. He will put these items on Auctions International.
- Airosmith Development (Blue Sky Tower) are in the process of completing their application for the Town of Elba Planning Board. In order to complete the viewshed analysis under SEQR they floated helium balloons to the height of the proposed tower and then proceeded to take photos. They will need to fill out the building permit to review at the March Planning Board meeting.

- Supervisor Hynes spoke with Jay Grasso, G&G Municipal Consulting regarding a grant for archiving records. It was discussed that we need to start scanning the Town's documents. Supervisor Hynes will discuss moving forward with this grant with Mr. Grasso.
- The 2020 census is coming up. A map was sent to Supervisor Hynes showing the boundaries. It will need to be signed and sent back.
- Supervisor Hynes read a letter from Ms. Barbie Starowitz regarding 7351 Bank Street Road. Supervisor Hynes stated she spoke with CEO/ZEO Mark Mikolajczyk recently, he had discussed this issue with instructors at a recent training he attended. They all had the same opinion that this is a preexisting, non-conforming condition. Mr. Mikolajczyk has been informed by our Town Attorney, David Schubel that he would be unable to enter the house unless permission was granted by the home owner. Town Clerk Werth and Deputy Town Clerk Itjen have reviewed all documentation left by prior CEO/ZEO's, that information has been given to Ms. Starowitz. With that said, a letter will be sent to Ms. Starowitz stating that the Town Board feels due diligence has taken place.

#### **Councilpersons**

- Councilwoman Marshall recommended that Councilman Augello review the Association of Towns website. She also encouraged him to set time aside next January for the training that they offer.
- Councilwoman Marshall stated the sales tax revenue is dropping in Genesee County. She recently learned that a travel agency that typically brings approximately 90,000 people to Genesee County does not currently have any tours scheduled. The Town will need to be conservative with what is taking place with the Counties budget and because of mandates.
- Councilman Chamberlain discussed an email received from Mr. Jeff Palmeri. He went over to assess the situation and told Mr. Palmeri that the Town would not be able to assist. He should contact the sheriff's department because of the damage.
