Building and Grounds

No report.

Zoning Board

- Councilman Chamberlain shared that Elton Shuknecht resigned after the meeting. The Zoning Board is now in need of two members. Supervisor Hynes to reach out to John Given for a letter of interest. The next meeting is Tuesday, September 7th, and there is a Pubic Hearing scheduled for G. Fiannaca of 7 Chapel Street. Councilman Chamberlain stated Mr. Sanfratello has been doing a good job leading the meetings.
- Councilman Chamberlain also shared that Mr. Rick Sanfratello, Chairman of ZBA discussed that he would like to see something in writing regarding the maintenance and up keep of the solar projects. While driving by neighboring towns projects it is evident that the trees are not be taking care of. Councilwoman Marshall suggested to look at the Town of Ridgeway's zoning laws because there is a solar project on Route 31 that looks like it has been well taking care of.

Planning Board

- Councilman Coughlin shared they are talking with Attorney Dwight Kanyuck regarding adding something to the zoning laws for wind. They believe he has a template.
- Mr. Joe Bridge is still working on documents for his land separation, he needs to submit a copy of mylar.

GAM

Supervisor Hynes shared that there was not an official GAM meeting in July, however they did meet for a special meeting regarding the fire services. MRI (Municipal Resources Inc.), a group hired by the County visited for four days to assist in evaluating how fire and EMS are currently provided in the County. They are also tasked to provide guidance based on emerging trends. The met with County and City leaders, major businesses, dispatch, City Fire and many other individuals. They will continue to collect data and expect to return one-two more times before winter and will have a final report by early spring.

Councilwoman Marshall would like to see this event held at the school or the recreation hall in case of rain or inclement weather. She stated it would be easier for residents to participate and hear questions and responses at one of these locations. Supervisor Hynes said she would talk with Mr. Luna regarding this request.
- WD2 Phase 7 continues, they are almost done with Pekin Road, working on Edgerton Road Friday and they will start Starowitz Road in a few weeks. There is still quite a bit of work to do.
- Councilwoman Marshall shared that the hydrants in WD1 are all discolored, very rusty and hard to see. Supervisor Hynes stated that she had a meeting with Town of Batavia and others next week and will discuss it with them.

Councilman Chamberlain shared that he and Councilman Coughlin attended the NYSERDA sponsored Charging Station Program in Albion last week. Discussion briefly ensued.
