Mayor Itjen moved to open the monthly meeting of the Village of Elba Board of Trustees at 6:00 PM seconded by Trustee Stempin.

The minutes from September 2021 were presented for review and approved.

The vouchers for payment were presented to the Mayor and Board and were signed and approved by Pflamuer and seconded by Howard.

Guest: Jeremy Liles from Oliver’s presented the board with concerns regarding the Ford Road drainage around his business at Olivers. The drainage issue is on the North side of Ford road between candy facility and road. There is nowhere for the rain to drain causing flooding and puddles and wearing down the road.

What can the village do? The Mayor will contact a CPL engineer to see if there is a fix. Nate Buczek will also take a look.

Jeremy advised that the Barbell gym will be moving across the street and the candy factory will be utilizing that space as they need more room.

Guest: Denis Rohan wanted to know the status of the sale of the property with the old well. (Behind ARC). The Mayor is speaking with our lawyer to see what is the best method to sell.

Denis also wanted an update on the Antenna on the Water Tower. Is it working? What is the delay? Clerk will contact Steve Mountain at the Town of Batavia for an answer. An email will go to Denis with his answer.

Denis also voiced his concerns of not wanting a school crossing guard as he feels its a waste of tax dollar money. At this time the board does not agree and the Crossing Guard will stay as many parents have asked we have one as Route 98 is a hard road to cross for small children.

Jerah Augello Clerk-Treasurer-
