He shared this was adopted by the Genesee County Legislature in 2001 and was identified as a mitigating action to the impacts of the County Water Project under SEQR. Smart Growth applies per the water agreements between the Towns and County and between the County and Monroe County Water Authority. This plan has a three year cycle review period.
