### Torrey Farmworker Housing- Jason Armbrewster Update

- J. Armbrewster of Armbrewster Design met with zoning board for Torreys pending farmworker housing project at 7148 Oak Orchard Rd and discussed zoning issues. There will be a public hearing next zoning board meeting to determining zoning designation.
- J. Armbrewster met with the Village to discuss the proposed project. The Mayor called back and said they would welcome the added sewer use. Additionally, Rick Albright (chief operator of the sewer plant) is supportive. There will have to be an out of district user agreement since the proposed project is located in the Town rather than the Village.
- The project will seek out a zoning variance next. A special use permit application may be provided to the Planning Board in Nov if board determines it is necessary. Board to review zoning laws to determine applicability.
