WHEREAS, pursuant to the Public Officers Law, said the meeting was open to the general public and due and proper notice of the time and place of the meeting was given as required by law; and

WHEREAS, the Town has in place certain Water Customer Agreements whereby the Town provides water to certain out-of-district customers; and

WHEREAS, the Town has one such Water Customer Agreement in place with A. Elizabeth Prinzi, residing at 7069 Transit Rd., Elba, NY 14058, for service to property located at 7069 Transit Rd., Town of Byron, County of Genesee, and State of New York by and through the Town of Elba Water District No. 2; and

WHEREAS, said agreement calls for a debt service charge of \$713.15 for the year 2024 with payment to be made within forty-five (45) days after receipt of the statement showing such charge; and

WHEREAS, the Town duly provided a statement to the customer for payment of the debt service charge at the time of signing the agreement; and

WHEREAS, forty-five (45) days have elapsed since the customer's receipt of said statement; and

WHEREAS, pursuant to N.Y. Town Law § 198(3)(a), if a property owner fails to pay the uniform service charge, a statement showing the name of the property owner and the amount unpaid and containing a brief description of the real property shall be transmitted to the board of supervisors of the county and such amount shall be levied and collected as an assessment against the real property;

RESOLVED, that the Town Board hereby acknowledges and declares that the above-referenced

customer has not paid their debt service fee for the year 2024, and the debt service fee owed has been outstanding for a period greater than forty-five (45) days; and be it further

RESOLVED, that the Town Board hereby directs the Town Clerk to transmit to the Genesee County Board of Supervisors a statement showing the name of the property owner and the amount of debt service charges left unpaid along with a brief description of the real property and a request that said outstanding amount be levied and collected as an assessment against the real property.

AGREEMENT FOR FUEL DISPENSING STATION

THIS AGREEMENT, made the 4th day of November, 2024 by and among the TOWN OF ELBA, with offices located at 7133 Oak Orchard Road, Elba, New York 14058, (hereinafter referred to as the "Town"), and the VILLAGE OF ELBA, with offices located at 4 South Main Street, Elba, New York 14058 (hereinafter referred to as the "Village"), and the ELBA FIRE DEPARTMENT, with offices located at 4 South Main Street, Elba, NY 14058 (hereinafter referred to as the "Fire Department"), and the ELBA CENTRAL SCHOOL DISTRICT, with offices located at 57 South Main Street, Elba, New York 14058, (hereinafter referred to as the "District").

WITNESSETH:

WHEREAS, the parties cooperatively use a common fuel dispensing station located on Town property adjacent to the Town Highway, currently consisting of two above ground storage tanks, and the appurtenances, one of which contains diesel fuel and once of which contains gasoline, and

WHEREAS, since approximately 1995 the parties have been jointly using and operating this station, and WHEREAS, the parties have not found a written Agreement signed by all four parties, and *Town of Elba – Regular Meeting* page 4 of 6 November 14, 2024

WHEREAS, the parties desire to place the terms and conditions for the future use and operation of this station in writing, as set forth herein.

WHEREAS, the District holds the NYSDEC permits for these tanks; and

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, it is agreed as follows:

1. Each party shall be jointly and equally responsible for any and all costs and expenses of any kind or nature related to the operation and maintenance of this system as well as their usage of fuel.
