Supervisor Hynes shared that Dwight Kanyuck, Solar Attorney will be here next week for the Planning Board meeting.

# **Councilpersons**

Councilman Chamberlain shared that he reviewed the original prints for the Cider Solar projects. He was not aware that they would be clear cutting all the trees and woods that they did. There is a lot of logging taking place for this project of 100+ year trees. He wrote a letter to send to the Governor, Representatives, DEC, Soil and Water, etc. Supervisor Hynes stated that Dwight Kanyuck, Solar Attorney, told her that the Town has no say and issues like this are to be handled by the people who signed the leases with the solar companies. Any complaints can be filed on the Cider Solar website. They are also still working on who will be taking care of the inspection. They are moving ahead with the project and there are no inspections currently taking place.

Councilman Augello suggested adding something to the Solar Law that limits properties from being covered on three sides. He also asked if the Town could speak with the County or other municipalities to see if there is a way too slow down the amount of solar coming? As it is coming at a fast pace. Is there a way for the Town to say that we have met our maximum amount for solar? Or only allow a certain percentage of someone's land to have solar on it?

Councilman Augello stated that the Town should start looking into a housing development. Supervisor Hynes shared that the Comprehensive Plan may help with this. Senior housing would be great in Elba.
